### **Application Information**

Always read the product label before use and take note of all the application instructions and usage regulations. Before treatment, remove all natural sources of food from the infested area to increase the likelihood of worker ants ingesting the microgranules and taking it back to the colony.



After a thorough check to determine the level of infestation, sprinkle the product on or near the ant nest. Also spread on surfaces where ants are frequently observed, at a dose of  $15-20~g/m^2$ . One 500~g container treats up to  $33~m^2$ 

#### **Other Information**

Store in the original container tightly closed. Store in a cool, dry, well-ventilated place. It is recommended to keep the product at a temperature between  $5^{\circ}\text{C}$  and  $50^{\circ}\text{C}$ .

Store in a safe place. Keep away from food, drink and animal feedstuffs. Keep out of reach of children and animals. Avoid release to the environment. Dispose of contents/container in accordance with local regulations. Do not reuse empty packaging.

Use biocides safely. Wash hands and exposed skin after use. Always read the label and product information before use.
