Application Information

Safeguard® Disinfectant Ready-For-Use is most effective when applied to a surface that has previously been cleaned.

Safeguard® Disinfectant Ready-For-Use can be applied by mopping, wiping or spraying. Apply the product to the surface and leave for a minimum of 5 minutes. This will give the disinfectant time to act. There is no need to rinse off the surface – it can be left to dry (except on food surfaces).



Food Contact Surfaces

Safeguard® Disinfectant Ready-For-Use can be used to disinfect food contact surfaces. However, it is important to ensure that the surface is disinfectant free before food comes into contact with it, by rinsing and wiping off after 5 minutes.
